conditions: -

- (a) No lame, blind, injured, sick or substituted animals will be loaded on road transports to ship or holding facility.
- (b) During transport to the authorized assembly depot no animals other than those described were loaded.
- (c) The livestock were born and raised in Australia.
- (d) To the best of my knowledge, livestock sourced for export comply with Australian food safety requirements, including standards for chemical residues or environmental contaminants.
- (e) I further declare: -
 - the animals are free from clinical evidence of the following contagious conditions: Actinomycosis, Trichophytosis (Ringworm), Contagious Ophthalmia/Bovine Keratoconjunctivitis (Pink Eye) and there has been no outbreak of these diseases reported on the property during the past **30 days**.
 - The animals and the property of export have been free of any known outbreaks or clinical signs for at least **6 months** prior to shipment for the following diseases : theileriasis, infectious pustular vulvovaginitis (IPV), Infectious Bovine Rhinotracheitis, bovine cysticercosis, intestinal salmonella infections (salmonellosis), Hendra Virus, Vesicular Stomatitis, Lumpy Skin Disease.
 - The animals and the property for export have been free of any known outbreaks or clinical signs for at least **12 months** prior to shipment for the following diseases: Anthrax, Anaplasmosis, Babesiosis, Theileriosis, Sporadic Bovine Encephalomyelitis, Surra.
 - All animals and the property of origin showed no clinical signs or abattoir evidence of Enzootic Bovine Leucosis (EBL), Bluetongue, Mucosal Disease/Bovine Virus Diarrhea (MD/BVD), Infectious Bovine Rhinotracheitis (IBR), 'Q' Fever, Ephemeral fever, Bovine Malignant Catarrh, Haemorrhagic Septicaemia and Leptospirosis during the previous **three (3) years**.
 - The animals and property have had no officially reported cases of Johne's Disease in the previous **five years**.
 - The following diseases are under control on the property of origin : dermatophilosis, clostridial diseases
 - The animals have never been fed with any kind of processed animal proteins (excluding milk protein for cattle to Vietnam).
 - The animals for export originate from properties which are officially free from Bovine Tuberculosis, Trichomoniasis, Bovine Brucellosis, and Bovine Genital Campylobacteriosis
 - The animals for export have been vaccinated against Botulism (buffalo to Indonesia only)
- (f) The animals to be exported are NLIS identified and registered on the NLIS database against the Property Identification Code (PIC) where they currently reside.
- (g) No animals are within a withholding period or Export Slaughter Interval for antibiotics. The cattle do not contain hormone growth promotant (HGP) residues at levels harmful to human health, as determined by Codex Alimentarius food safety standards.
- (h) I give permission for the relevant State Department to disclose animal health information relating to my property to a third party, for the purpose of the export of live animals that have resided on my property.

Note : Commonwealth legislation provides that giving false or misleading information is an offence, with penalties up to five years imprisonment.

representative of the above mentioned property, declare to the best of my knowledge, the animals prepared and handled for export have met with any relevant road transport requirements under state or territory legislation and relevant requirements under the national Model Codes of Practice for the Welfare of Animals. ASEL 3.0 Standard 2 (Standard for Land Transport of Livestock) and OIE (World Organization for Animal Health) Chapter 7.3 (Transport of Animals by Land). Please sign below if you conform to these requirements.

- A travel plan has completed for all journeys of more than 8 hours duration and interstate journeys greater than 2 hours.
- Livestock have been mustered and handled to prepare for land transportation to maintain health and fitness for travel. Feed and water curfews are to be observed.
- Livestock were inspected prior to loading and any animal showing signs consistent with the rejection criteria in ASEL 3.0 (S1.1.6) and Table 1 (Rejection Criteria for all species by sea) or any other condition that may cause animals health to decline were not loaded. The owners and managers of the livestock are responsible for the general health, overall welfare and fitness of the animals for the journey (OIE A.7.33)
- Ensure vehicles are of appropriate design, clean and in maintained in good working order, for the type of livestock transported. Transport operators are responsible for this requirement and must maintain a journey record.
- Livestock drafted and loaded for transport by land were separated by class, species and size. Livestock with horns over 12cm separated from other livestock. Livestock not to be loaded until a travel plan is completed
- Livestock were loaded in a manner that prevents injury and minimises stress including loading densities and penning arrangements. The person responsible for the land transport vehicle must be responsible for the livestock (ASEL 3.0 Standard 2 Land Transport of Livestock)
- Working dogs are not transported in the same pens as livestock. Livestock will be unloaded and rested as specified in (Land Transport of Livestock edition One Version 1.1) and in accordance with state/territory legislation. At unloading the livestock will become the responsibility of the management personal of the registered premises. Distressed or injured livestock must be given immediate assistance. Humane euthanasia to be carried out if necessary (ASEL Standard 2 Land Transport of Livestock)
- Livestock will be unloaded into registered premises by competent stock handlers in a manner that prevents injury and minimizes stress as per ASEL 3.0 (3.1.13 – 3.1.15).

It is a requirement of the Australian Livestock Export Standards (Version 3.0) "when receiving and identifying livestock, the Depot Operator must obtain a copy of the Vendor Declaration/s regarding the property of source and health status of the livestock before accepting the livestock for the purpose of preparation for export".
